 - A. Should transcripts contain a list of activities?
 - B. There are have been some transcripts where the activities have been listed incorrectly. As a result, these questions have been brought forward:
 1. Is there an official policy stating what is and isn't allowed on a transcript? If so, where is the policy located?
 2. What is the process for reporting an error?
 3. Are only lettering activities allowed on transcripts? What about clubs where only the President is allowed to letter? What if you can letter, but do not? Does that still belong on the transcript?
 4. What activity is worthy to achieve letter earning status?

5. Spanish Passing Policy: Kassie 8:25
Students who are following the standard course sequence will be allowed to continue to the next level as long as they earn a final year course grade of C- or higher. Students who are unable to achieve the required minimum grade at the end of the year, must repeat that course the following school year. Students are required to take and pass each level in order to meet MSA's graduation requirements.
