3. Motion to approve a new amended school calendar with March 12, 2018 designated as an e-learning day.

Discussion: BOD reviewed survey that was emailed to staff and parents regarding preferences for making up the snow day from March 5th. 72% of the staff who responded preferred the option to have March 12th be used as an e-learning day. Parent responses were split between having March 12th be an e-learning day (43.75%) and having March 12th be a regular school day (38.87%).

BOD reviewed benefits of having an e-learning day instead of a regular school day:

- As a result from a committee formed last year, e-learning days will be the default for canceled school days next year. At Wednesday's staff meeting, interest was expressed in having the 12th be used as a trial for this platform to have the opportunity to preview any issues with it that can be corrected before next year.
- The Robotics team will need to catch up on missing assignments on Monday since they were at a competition all weekend, causing difficulty with their members participating in a regular school day when they expected it to be a non-school day.
- Teachers have their days planned, as this day was to be a teacher work day.

Logistics of an e-learning day on March 12th were discussed:

- Teachers were scheduled to attend a training which will need to be cancelled due to their need to be accessible during the day. Director explained this training was supplemental and can be distributed via email instead.
- Teachers are to assign lessons within the units they are working on in their classes. Lessons are to be posted by 10:00 am.
 - To accommodate students without internet access or printers at home, assignments would not be due the next day, but rather on a date determined by each teacher.
